Who Qualifies?

Anyone can have spirit! However, only non-profit organizations with a 501(c)(3) tax-exempt number, and recognized by the government as a non-profit organization (or authorized group) qualify for Spirit Days. For more information and 501(c)(3) tax status, please visit www.irs.gov. **Individuals are not eligible.**

How to Raise Spirit:

1. Complete a Fajita Pete's Spirit Day request form. One can be completed online at:
 - <http://www.fajitapetes.com/donations-fundraising/>
 - A. Spirit Days are available for scheduling Monday-Wednesdays throughout the year. The event takes place 4 pm- close.
 - B. Complete a request form on our website to book a date. The requested date is not a guaranty, and it will need to be approved before moving forward. The total number of dates available for spirit nights for all locations will be limited and first come, first serve.
2. Once approved, we'll send you an email to finalize plans for your event. The event must be confirmed 2-weeks in advance.
3. Fajita Pete's has created a Spirit Night flyer with all the details for your event, specifically for Spirit Night. A PDF version of this announcement will be emailed to the contact.
4. Advertise! Email, add a link to the flyer to your website, post on all social media, announce the spirit night at your games/ events.
5. Your organization will receive 15% of each sale when a customer states that they are there for the fundraiser. Your donation check will arrive 2-4 weeks after the event date.

How Does it Work?

- **PICKUP, DINE-IN, and "Call-In" DELIVERY. There will NOT be an online Spirit Night button available.** Customers that want to participate and want delivery will need to call to order.
 - Cannot be combined with other offers.
- Your organization is entirely responsible for advertising your event through all means possible: printing and handing out flyers in person, communicating with family & friends, publishing in newsletters/local papers, posting on Facebook/Twitter and mass emails.

- On the day of the event, the physical Fajita Fete's Spirit Night flyer is not necessary to receive the donation. One must only inform their server or Fajita Pete's staff member that they are there for the fundraiser.
- There is to be no advertising of the event once you are inside the restaurant. Telling your table neighbors or strangers sitting down to eat about the fundraiser, is strictly prohibited. Doing so will result in Fajita Pete's asking the organization and person(s) to cease their action immediately, and the event will be subject to cancellation. We appreciate your cooperation.

Helpful Tips:

Once your Spirit Date has been finalized, and you've received your customized flyer, take these steps to ensure your fundraiser is successful:

- Put a flyer in your school's newsletter- Post on your marquee.
- Announce your Spirit Day on your web site and attach the PDF flyer.
- Attach the flyer to an email going out to family, friends, coworkers, etc.
- Call your local newspaper or community publication.
- Pass out flyers during the large gatherings, group meetings, and area sporting events.
- Announce the fundraiser at your school or local event.
- Post the flyer on your organization's social media pages.

Donation Amount & Payment:

For each ticket participating in the fundraiser, a discount of 15% will be taken from the total receipt (before sales tax and fees). You will see on your receipt the 15% discount labeled, "Spirit Night". After the event, a report with the total amount will be determined.

Organizations will receive the total up to \$500. Gift Card/ Certificate purchases do not apply to the check total for Spirit Night events. When calculating donation amount, subtract any gift card/ certificate sales from the subtotal. The subtotal is before sales tax and any fees applied.
